W I T N E S S E T H :

WHEREAS, Declarant is the owner of Lots and Property within Cherokee Ridge Subdivision, and pursuant to Article VII, Section 3.B. of the Declaration of Covenants, Conditions and Restrictions of Cherokee Ridge Subdivision (hereinafter referred to as "Declaration") as the same are filed for record in the Probate Office of Marshall County, Alabama in Book 1114, Page 22 et seq., Declarant desires to amend certain provisions of said Declaration.

1. Article IV, Section 1.D. Tree Removal. is modified by striking "twenty (20)" and substituting therefor "ten (10)".
2. Article IV, Section 1.K. Signs. is hereby deleted in its entirety and the following is substituted therefore:

Signs. One sign and/or one real estate sign of a design and size approved by the Committee, providing the telephone number to call for information regarding the sale of the lot, may be placed on each lot. In the event such lot borders the Golf Course, at the option of the owners, two approved signs may be placed on such lot, one facing the Golf

Course and another facing the street. Otherwise, signs are prohibited.

3. Except as amended herein, all terms, restrictions and covenants of the Declaration shall remain in full force and effect.
